Subject: Request for Variance Allowing Street Parking

It is crucial to acknowledge that modern vehicles have grown in size compared to their predecessors. The construction of most household garages in Branford Village no longer accommodates larger vehicles such as SUVs, trucks, or full-size cars, which have become

prevalent in our community. Granting this variance would address the practical need for parking spaces that suit these modern vehicle dimensions.

In conclusion, the Branford Village HOA kindly requests your consideration in granting the variance that allows parking on the streets while ensuring that parked vehicles remain on the side of the sidewalks, prioritizing emergency vehicle access and pedestrian safety. ## **Proposed Changes:**

## Parking on One Side of the Street:

- Allow parking on the side of the street where there are sidewalks only.
- Prohibit parking on the sidewalks to ensure unobstructed pedestrian pathways.

### Sidewalks and Driveways:

 Homeowners with sidewalks must stay within a reasonable amount of parking, ensuring that sidewalks crossing driveways remain clear for pedestrian use.

#### **Emergency Vehicle Access:**

 Parking on one side of the street allows for sufficient width for emergency vehicles to navigate without obstruction.

## **Snow Emergency Regulations:**

- During snow emergencies, there should be no parking on the streets to facilitate effective snow removal by the township.
- Residents are encouraged to use alternative parking arrangements during these periods.

#### **Corner Clear Vision:**

 No parking within 50 feet of corners to ensure clear visibility at crosswalks and intersections, promoting pedestrian and traffic safety.

#### **Enforcement and Penalties:**

- Violators of the new regulations will be subject to fines imposed by the Township Police Department.
- No "saving" of spots will be allowed; streets will remain public domain and open for parking within the new guidelines.

# Rationale:

- Pedestrian Safety: Clear sidewalks and unobstructed pathways ensure safe pedestrian circulation throughout the neighborhood.
- Emergency Access: Adequate street width facilitates swift access for emergency vehicles, ensuring the safety of residents.
- Snow Emergency Preparedness: Prohibiting parking during snow emergencies enables efficient snow removal and minimizes disruptions.
- Traffic Visibility: Maintaining clear vision at corners enhances overall traffic safety and reduces the risk of accidents.
